This document shows the questions included in the online application form for this grant opportunity. It will help you prepare your responses and the mandatory attachments you need before you apply online.

Instructions

The online form captures the information required by the department to assess and manage your application for services and funding.

The first page of the application page contains the following instructions.

Completing your application

The application consists of separate pages as shown in the navigation menu on the left hand side of the portal page. You can navigate between pages using the menu or the buttons at the bottom of each page.

A warning message may appear if you have not completed all of the mandatory questions or if there is an issue with information you have entered. If a question is not mandatory it will be clearly marked – Optional.

Saving your responses

You can save your changes at any time by using the Save button.

To prevent you losing your work you should save often. The portal will time out after 30 minutes if you do not save. Typing or moving your mouse does not reset the time out.

You must use the Save and Continue button to validate the information on each page. If you use the menu to navigate between pages, you will be prompted on the final page to go back and validate all of the information you have entered. A green tick indicates a validated page.

You can modify saved responses up until you submit your application.

Participants

You may invite others to assist in completing your application via the application summary page. To do this:

- Select the Participants button
- Enter the details

An email will be sent to your participant inviting them to assist with your application.

Submitting your application

You must complete every page of the application before you can submit.

You must also read and agree to the declaration which advises you of your responsibilities.

Check all your answers before you submit your application. After you submit, it will no longer be editable.

A. Program selection

Before you start your application, we need to first identify what type of entity is applying.

If you are a trustee applying on behalf of a trust we will need details of both the trust and trustee.

Before you start you should have the following details ready if they are applicable to you.

Provides Australian businesses with grants to build capacity to deliver products and services into domestic and/or international space supply chains that could support Moon to Mars activities.

B. Eligibility

We will ask you the following questions to establish your eligibility for the Moon to Mars Supply Chain Capability Improvement grant opportunity.

Questions marked with an asterisk are mandatory.

- form a sufficiently significant proportion of the corporation's overall activities as to merit it being described as a trading corporation; or
- are a substantial and not merely peripheral activity of the corporation.

Are you registered for the Goods and Services Tax (GST)

You must answer yes to proceed to next question

Can provide clear evidence, for example a letter of intent or contract from your customer that demonstrates you have a domestic and/or international space supply chain opportunity? *

You must answer yes to proceed to next question

Can provide evidence from your board (or chief executive officer or equivalent if there is no board) that your project is supported, and that you can complete the project and meet the costs of the project not covered by grant funding?*

You must answer yes to proceed to next question

Can provide an accountant declaration that confirms you are a trading corporation and can fund your share of the project costs, including any ineligible expenditure.

C. Applicant address

D. Key contacts

E. About your organisation

We collect the following data from all applicants. We use this data to better understand your organisation and to help us develop better policies and programs.

F. Project information

Ensure your project description focuses on your project's key activities and outcomes. Outline what it is you are going to do and how it will benefit your supply chain capability.

F.2. Detailed project description and key activities

This information will be included in your grant agreement if your application is successful.

Provide a detailed description of your project including the project scope and key activities.

Your response is limited to 5000 characters including spaces and does not support formatting.

F.3. Project outcomes

This information will be included in your grant agreement if your application is successful.

Provide a summary of the expected project outcomes.

Your response is limited to 5000 characters including spaces and does not support formatting.

F.4. Project duration

Your project must be completed by 31 December 2026.

The start and end dates you enter here will drive the visible financial years in the project budget on the next page.

The project length will be calculated by the start and end dates you enter.

- Estimated project start date
- Estimated project end date
- Estimated project duration (in months)

F.5. Project milestones

Provide details on the project milestones including the key activities occurring at each milestone.

The milestone start and end dates must be within the project start and end dates. You can add up to 10 milestones.

- Milestone title

Your response is limited to 100 characters including spaces and does not support formatting.

- Description

Your response is limited to 750 characters including spaces and does not support formatting.

- Estimated start date

F.6. Project location

You must provide the address where your project will be undertaken and the estimated percentage of project value expected to be undertaken at that site. If you have multiple sites you must add the address of each site.

A project location must be a street address. Do not provide a postal address, institution or building name.

F.7. Disclosure of financial penalties

F.8. Foreign affiliations

Does your project receive any funding or non-financial support from a foreign source?

Do any entities or key personnel involved with the project receive financial support or benefits from a foreign source?

If yes, provide details of the arrangement.

Your response is limited to 750 characters including spaces and does not support formatting.

Do any entities or key personnel involved with the project have any current or former association with a foreign talent program?

If yes, provide details of the foreign talent program.

Your response is limited to 750 characters including spaces and does not support formatting.

Do any entities or key personnel involved with the project have any ties to a foreign government, military or state-owned enterprise?

If yes, provide details of the affiliations or associations.

Your response is limited to 750 characters including spaces and does not support formatting.

F.9. National security plan

Does your organisation have a plan or framework in place to manage any potential security risks associated with the project and your organisation more broadly?

This includes protecting your organisation from potential national security risks including cyber security threats and the secure handling of data. We may ask for a copy of your plan or framework at a later stage.

Provide details about all project partners.

For details about project partner contributions refer to the grant opportunity guidelines.

If a project partner is a trustee applying on behalf of a trust we will need details of both the trust and trustee.

You must provide:

H. Project budget

Provide a summary of your eligible project expenditure over the life of the project.

H.2. Source of funding

In this section you must provide details of how you will fund the project.

The total of all sources of funding, should be equal to your total project expenditure in the section above. Sources of funding include:

I. Assessment criteria

We will assess your application based on the weighting given to each criterion and against the indicators listed beneath each criterion. We will only consider funding applications that score at least 50 per cent against each criterion as these represent best value for money.

The amount of detail and supporting evidence you provide should be commensurate with the project size, complexity and grant amount requested. You should define, quantify and provide evidence to support your answers.

I.1. Assessment criterion 1 (40 points)

Your response is limited to 5000 characters including spaces and does not support formatting.

How your project will grow your skills, capability and capacity to participate in domestic and/or international space industry supply chains

You should demonstrate this by identifying

- a. the strength of your domestic and/or international supply chain opportunity, including details of your customer and certainty of opportunity (e.g. letter of intent or contract)
- b. how your domestic and/or international supply chain opportunity has the ability to support Moon to Mars activities
- c. how your domestic and/or international supply chain opportunity will support your business to grow now and into the future
- d. how your project will help you meet your domestic and/or international supply chain opportunity
- e. the skills, capability and capacity you will develop.

You must provide strong evidence of your domestic and/or international supply chain opportunity to be successful against this criterion.

I.2. Assessment criterion 2 (30 points)

Your response is limited to 5000 characters including spaces and does not support formatting.

Your capacity, capability and resources to deliver the project (30 points)

You should demonstrate this by identifying:

- a. how you will leverage existing capability, including through current and new partnerships
- b. your track record in managing similar projects, and your access to personnel with relevant skills and experience, including project management and technical staff
- c. your access to any required infrastructure, capital equipment, technology and intellectual property
- d. your project plan, including your plan to:
 - manage the project including scope, implementation methodology and timeframes
 - mitigate delivery risks (including national security risks)
 - secure required regulatory or other approvals.

You must attach a project plan and budget to your application.

I.3. Assessment criterion 3 (30 points)

Your response is limited to 5000 characters including spaces and does not support formatting.

The impact of grant funding

You should demonstrate this by describing:

- a. how your project will build Australian industry ability to support Moon to Mars activities
- b. benefits to the Australian space industry, including the uniqueness of your product, process or service and the extent it provides a competitive advantage to Australia
- c. the broader economic impact of your project, including spill over effects in other areas of the economy and anticipated direct/indirect employment growth
- d. any additional investment the grant will leverage, including quantified direct and in-kind contributions to the project.
